* Denotes fisheries that may have daily catch limits imposed or be closed immediately by Order of PRFC subject to the ASMFC/MAFMC established commercial landing quotas.

** **Pound Netters** using fish cull panels as defined in Reg. III, Sec. 8(d) may possess up to 50 lbs. (1 bu.) of legal size weakfish from February 15th through July 27th. The allowance must be less than or equal to the poundage of other lawfully harvested species.

*** When the menhaden catch limit is reached, all commercial fisheries shall be closed; however, gill net, fyke net and pound net licensees are permitted to possess and/or land no more than 6,000 lbs. or 12,000 lbs. if two licensees are fishing together of menhaden for a single vessel per day.

SIZE LIMITS

Season: January 1 through February 14.....18" min. – no max.
 February 15 through March 25.....18" min. & 36" max.
 June 1 through December 31.....18" min. - no max.

Yearly Quota: 81,959 lbs. (12,530 tags) total for all licensees

POUND NET

SIZE LIMITS

Season: February 15 through March 25.....18" min. & 36" max.
 June 1 through December 15.....18" min. – no max.

Yearly Quota: 127,748 lbs. (23,000 tags) total for all licensees

MISCELLANEOUS COMMERCIAL GEAR

SIZE LIMITS

(Qualifying Haul Seine and Fyke Net Only)

Season: February 15 through March 25.....18" min. & 36" max.
 June 1 through December 15.....18" min. – no max.

Yearly Quota: 13,749 lbs. (2,300 tags) total for all licensees who have reported harvest of species other than striped bass using that particular gear type for the last 3 years.

Haul Seine 60% - 1,380 tags total for all licensees
 Fyke Net 40% - 920 tags total for all licensees

GILL NET (2021 – 2022 SEASON)

SIZE LIMITS

Season: November 8, 2021 through February 14, 202218" min. – no max.
 February 15 through March 25, 2021.....18" min. & 36" max.

Yearly Quota: 349,405 lbs. total for all licensees

Setting Nets: Each licensee shall be permitted to set and fish a single properly identified net in the number of their licensed locations (stands) as follows:

November 8, 2021 through February 28, 2022 all stands
 March 1, 2022 through March 15, 20224 stands
 March 16, 2022 through March 25, 2022 3 stands
