## Potomac River Fisheries Commission Meeting

Colonial Beach, VA —

Chairman Wayne France announced today the Potomac River Fisheries Commission will hold its next regular meeting on **Friday, March 5, 2021 at 8:30 a.m.** via GoToWebinar (webinar information below). Chairman France invites all interested persons to attend this open public meeting.

The advertised public hearing will include the following: to amend Regulation 1, Sec. 4 - addition new outline designations and adding Section 4(a)(iv) in order to review license status in foreign jurisdictions, and accordingly restrict Commission license if restricted, revoked, or suspended elsewhere; to amend Reg. I, Sec. 2(d)(5)- eliminate the inactive crab pot status and requiring all crabbers to pay for their CP ID tags/decals at renewal or pay the administrative fee for CP tags/decals ordered after the renewal period ends; to amend Reg. I, Sec. 2(g) - enhance the oyster buy boat license language; to adopt Reg. III, Sec. 13(g) - establish a new regulation allowing a commercial hook and line transfer to a gill net; to amend Reg. III, Sec. 13(d) – add language for a transfer from a commercial gill net to a hook and line license and establish a transfer fee; to amend Reg. III, Sec. 11(b) - revise the method of fish measurement; to amend Reg. III, Sec. 10(b) - require an audit fee on any person for a striped bass tag audit; to amend Reg. VIII, Sec. 1 - add new language for the dissolution of program; and, to amend Reg. I, Secs. 2(l)(1), 2(m)(1), and 2(m)(2) adjust issuing a fish trot line, fish pot, eel pot, or bait pot license to a natural person instead of a boat. Items on the agenda include: reports on the 2020 crab, fish, and oyster harvest; a summary of the August ASMFC meeting; summary reports from the BCAC, FFAC, and the OCAC meetings; an update and presentation on the ACCSP proposal; modifications to the membership and procedures for advisory committees; 2021 oyster plantings; and biological reference points.
